AUTUMN LEAF CUP

The fleet assembled 10/19/91 at Howard Amon Park and looked with fear and trepidation at the conditions on the water, no, it wasn't the wind, but rather the current and lack of wind. Four new crews and boats were preparing to take part in their first CBSC race this year. Rick Wright in his O'Day daysailer, Larry Johnson in his Laser II, Steve McConaghy in his C-Lark, and Scott Petersen in his Interclub dinghy. A short windward, leeward course set up for the north wind was chosen in light of the conditions and they were off.

Al Hopp nailed the start and headed up along the newly refurbished Howard Amon beach to the north utilizing the amazing and considerable "eddy" that produced an upstream current along the shore. The fleet followed dodging the geese and the sprinklers that were coming on intermittently along the shore's newly planted grass (that's how far everyone was in). Al rounded the windward mark (I guess you could call it that) but without sufficient "oomph" to carry him around it the current brought him into the mark and he was forced to do his penance via 720. This produced enough of a gap for Paul Reeder in the "Electric Radish" to surge into the lead.

Morely Paul in the Holder 20 and Al Hopp got into congestion midway to the finish, the prevailing wisdom of the on the water jury produced another 720 penalty, this time by Morely. This bit of confusion produced enough of a gap for Ken Dyer to squeak by into the second spot, Morely ended up finishing third and Al Hopp ended up in fourth.

In the non-member "New Leaf" fleet Rick Wright was first to finish (Rick promptly paid his membership and is now ineligible). The battle for 6th and 7th was close with McConaghy finishing 2 seconds behind Larry Johnson's Laser II in a bang, bang finish. In the end the corrected time brought Steve McConaghy out on top for a

6th overall.

FROSTBITE RACING NEWSLETTER (It only feels chilly in the parking lot)

11/2/91 Considering the time of year and the somewhat bracing temperatures, we had a really good turnout for Saturday's race: 7 1/2 boats (Dick Quigley didn't bring his boat, rescuing John Werner from sailing solo).

The winds were extremely challenging, ranging from minus 1 (pushing you backwards) to intermittent gusts capable of causing a capsize if you weren't paying attention. Starting out in the north, they did some major directional shifting, switching at times 90 degrees in about three seconds. The shifts were predictably oscillating rather than clocking, and boat to boat tactics were thus less important than figuring out where the new puffs would be filling in and being there. It would certainly be interesting to read an article by our atmospheric scientist (initials, JH) member on the physical explanation of this wind behavior.

We were delighted to see Rick Wright (Geoff Harvey crewing) out for the second time, and Steve McConaghy (solo).

Ken Dyer (with Gary Smitt) and Al Hopp (with Mike), finishing 1-2, 2-1, did the best job of solving the wind velocity and direction challenges, followed closely (especially in the first race) by Ken Nelson, possibly inspired by his very glamorous and capable other-woman crew (identified by the Sailing Results in the Tri-City Herald as Wanda Haddon).

Race Committee Dennis Trimble put out a pin end mark downstream along the swim dock, a windward mark on the north shore (3) and used the white buoy below the campgrounds (4) for a leeward mark, a starboard rounding triangle, then pin end to (3)S and then back to finish for the first race. The wind changed the windward-leeward reach plan to a five-reach asbuilt.

Dyer late at the start, recovered by the first mark and held the lead to the finish first. McConaghy passed Hopp on the second leg but went a little low and got out of the wind. Hopp held high, caught the wind to take over second place just before the start of the finish lap and held it to the finish. Nelson got by McConaghy to finish third, 8 seconds behind Hopp on CET.

Second race was two triangles, the first a start, 3 and 4 starboard rounding, and the second a reverse port rounding of the pin end buoy, 4, 3 and finish. Nelson caught Dyer just before (4)P on the second triangle and was able to hold starboard tack all the way to (3)P rounding in the lead and heading straight to the finish line. However, Dyer solved the wind puzzle best by going left and holding to finish first. Nelson tried to hold off Hopp on his right by a drastic and forceful up-up-up but crossed the finish line 8 seconds behind Hopp scratch and somewhat more corrected. Casey and McConaghy, after struggling to round a gusty 3 in an upright position, sailed right into a bottomless pit and almost didn't ever make it to the finish line.
